

WILD HORSE PHOTOGRAPHY WORKSHOP AGREEMENT

This Wild Horse Photography Workshop Agreement is entered into on this _____ day of _____, 20 _____ by and between:

Barbara Bostock hereinafter referred to as the “Workshop Organizer”, with an address at 235250 Range Rd 41 Calgary, AB T3Z 2H8; and

BACKGROUND:

The Workshop Organizer is hosting a Wild Horse Photography Workshop (the “Workshop”) that the Participant wishes to attend. The Parties desire to formalize the terms and conditions for the Participant’s attendance at the Workshop.

AGREEMENT:

1. Workshop Details:

The Workshop will span approximately three days and two nights, finishing early on the third day. There are three available workshop dates to choose from:

June 10-12, 2024

June 24-26, 2024

September 16-18, 2024

The cost of the Workshop is \$700 per person.

2. Deposit:

To reserve a spot in the Workshop, the Participant is required to make a non-refundable deposit of \$350 upon signing this Agreement.

3. Payment Schedule:

The remaining balance of \$350 must be paid in full no later than 30 days before the scheduled start date of the Workshop. The total cost of the Workshop is due by **Payment Due Date**.

4. Cancellation and Refund Policy:

The Deposit is non-refundable under any circumstances. If the Participant cancels their attendance in the Workshop at least 30 days before the scheduled start date, the Deposit will be returned in full.

5. Included Meals and Dietary Preferences:

The Workshop fee includes the following meals:

☑ 2 packed Lunch for the trail

☑ 2 Breakfast Meals

All meals will be at the Workshop Organizer’s discretion. Participants are kindly requested to inform the Workshop Organizer of any dietary restrictions or food allergies and we will do our best to accommodate your dietary preferences. Participants will be accommodated in a shared three-bedroom cabin with a full kitchen. Participants are responsible for providing their own snacks and drinks, including alcohol for evening consumption.

6. Workshop Schedule:

A detailed Workshop schedule, including photography sessions and activities, will be provided to the Participant prior to the Workshop start date.

7. Photography Rights:

The Participant acknowledges and agrees that any photographs or materials created during the Workshop may be used by the Workshop Organizer for promotional, advertising or other purposes, without compensation to the Participant.

8. Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta.

9. Entire Agreement:

This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements and understandings, whether written or oral, concerning the subject matter hereof.
